1. Form of proxy

- 1.1 As a member of NFAN you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at an EGM of NFAN Ltd. You can only appoint a proxy using the procedures set out in these notes.
- 1.2 Appointment of a proxy does not preclude you from attending the meeting and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.

2. Appointment

- 2.1 A proxy does not need to be a member of NFAN Ltd but must attend the meeting to represent you. If you wish to appoint a proxy other than the Chairman of the meeting, insert their full name in the box. If you leave this space blank, the Chairman of the meeting will be appointed your proxy. Where you appoint as your proxy someone other than the Chairman, you are responsible for ensuring that they attend the meeting and are aware of your voting intentions.
- 2.2 You may appoint only one proxy to vote on your behalf and represent you.

3. Voting directions

- 3.1 To direct your proxy how to vote on the resolutions mark the appropriate box with an "X". If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion.
- 3.2 Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the meeting, including a motion to adjourn.
